The Board has come back and hit the ground running, as we have many initiatives that we are currently working on – Staff Appreciation, Preferred Future, High School Modernization, as well as the release of the Provincial Budget. We are also in a Board election year and we are about to start the nomination process!

In March, we said goodbye to Bill McGregor, a FFCA Board member for 12 years and Board Chair for 10 of those years. Bill was committed to choice for parents in public education and was a passionate ambassador for FFCA and for Charter Schools. Bill's tireless work with government on behalf of FFCA and all Charter schools was key in opening doors for all of us. On March 26<sup>th</sup>, the Provincial government released the much awaited budget. With the release of the budget, the Board has been busy working to determine the impact it will have on our school. The budget that was announced will safeguard our classroom teachers, but will not allow for any student growth. Boards were also told to reduce all costs other than classroom based teachers by 2.7%. We are all aware that we are in economically challenging times, and your FFCA Board is working hard, along with our Superintendent Roger Nippard and our Secretary-Treasurer Reta Morgan, to ensure that meeting the needs of our students comes first and that we provide the best education we can with the resources we have been given.

At the end of March, FFCA was invited to participate in a press conference held by Premier Jim Prentice, Education Minister Gordon Dirks, and Infrastructure Minister Manmeet Bhullar, to announce their commitment to funding of Phase 2 for our High School. We previously had only the funding for planning and design of phase 2, but it was announced that we have now been given the full funding. This commitment was given by our Premier during these economically challenging times and we are incredibly appreciative of their support for Charter Schools through this funding. We have had great support along the way, and we couldn't be where we are today without the work of our elected government officials working on our behalf with us and behind the scenes.

Thank you to our Board of Directors for all their work and their commitment to FFCA. Our current Board's three-year term is up at the end of May. We will be holding elections with nominations starting on April 24<sup>th</sup> and closing on May 1<sup>st</sup>. Board Directors are responsible for ensuring the best needs of our students are met, and for representing the interests of our stakeholders.
